#### **1. GAJE news and events**

**News:** Extension of **Early Registration Deadline for the GAJE 2006 World Conference in Cordoba, Argentina (27 Nov-2 Dec 2006)**

**Details:** Early Registration for the 4<sup>th</sup> GAJE World Conference has been extended to 15 October 2006 and can be done online at ([www.gaje.org](http://www.gaje.org)). Please be reminded that **early registration** conference fee is US\$ 350 which **will rise to \$450 after October 15.**

**Event: GAJE Conference in Cordoba, Argentina (27 November – 2 December 2006).**

**Details:** The upcoming GAJE Conference in Cordoba, Argentina will focus on the theme: 'Educating Lawyers for Social Justice: Law, Poverty and Social Change'. The Conference Planning Committee has received over 35 proposals for sessions, all of which were of a very high quality. The Committee is in the process of finalising the draft timetable, which will be posted on the GAJE website very soon.

The conference will be interactive, drawing on the experiences of participants, and it will focus on the following five streams:

- A – Addressing unmet legal need – legal service alongside legal education
- B – Professional responsibility and social change – educating lawyers in social justice
- C – Socially relevant legal education – matching the curriculum with social needs
- D – Poverty, reform and education – effecting change through education and research
- E – Public legal education – the role of law schools in improving legal literacy

#### **2. Other events and courses**

**News: Report on a Teachers' Training Workshop "Building Capacities: Learning From Each Other"**

**Details:** A Teachers' Training Workshop on the theme "Building capacities: Learning from each other" was held at the Law Centre-I, Faculty of Law, University of Delhi in April 2006. The report of the proceedings and outcomes of the workshop edited by Prof. Ved Kumari was formally launched by Prof. Jane Schukoske during the Commonwealth Legal Education Association Regional Conference held in Delhi on 28-30 July 2006.

The design of the workshop was inspired by GAJE Conferences' workshops and similar international fora and reflects how international collaboration has a ripple effect even after the formal interaction ends. The workshop provided an occasion for teachers to learn some new and participatory teaching methods, changing their perspective from teaching to learning by students. More importantly it channelled their thoughts to some very fundamental questions regarding law teaching such as: What is law teaching about? What do we want students to do with the education that is given to them in law school or any institution of higher education? Should teachers focus primarily on creating efficient lawyers, professionals well versed in the techniques of their profession or should they be aware of the social context in which their actions will affect people in different ways?

It also brought to the fore the disjuncture between teaching objectives and evaluation systems. While there is consensus that legal education should strive to create efficient and socially committed lawyers, that policy finds little reflection in the evaluation criteria used or in setting of the questions for evaluation. The workshop made participants realize that most of the times the justice component is not integrated in the whole process of legal education consisting of course formulation, teaching methods, question settings and evaluation criteria. The workshop led to introspection by participants and a desire to think through the teaching process carefully and ensure that they are able to make a contribution in promoting justice in society through education.

The report will be a useful resource for people interested to conduct such workshops in their own schools, conduct research or just reflect on what they do and whether there is need to think and work further to achieve better or desired results for securing justice through education. **Details:** The ABA seeks a Deputy Director of its Morocco Program, with primary responsibility for management of a gender- and human rights-focused curriculum development project. The Deputy will also assist with the management of a human rights legal clinic at a university near Rabat, and with selected aspects of the overall management of the Morocco program. The Deputy will work under the supervision of a Director and with local staff on-site, and in consultation with ABA program and administrative staff in DC and elsewhere in the region, as well as working closely with local partners and government officials.
