**Course:** Inter-American Bilingual Summer Abroad Program, University of the Pacific McGeorge School of Law in both Sacramento and Guatemala

**Dates:** Summer 2009

**Theme:** The program will help students become linguistically and culturally competent lawyers who will be able to combine a U.S. and Latin American practice of law. Students who are proficient in Spanish will take a two-unit course in Sacramento during May, to be taught primarily in Spanish, that will introduce them to the social, cultural and legal history of Guatemala. Following the introductory course, students will travel to Guatemala and will participate in a ten-week legal externship with either a Guatemalan state agency or a non-government organization in that country. During the period of the externship, students will also be enrolled in a regularly scheduled comparative law course in the law faculty of Guatemala's Landivar University, a private Jesuit school with a long tradition of educating with a social justice mission in the country.

The internship aims to produce a tangible work product that will be utilized in the communities in which BABSEA works, and will directly result in disadvantaged populations gaining greater awareness of and access to their legal systems, as well as helping to provide support to our partner universities and organizations. The legal interns gain a greater understanding of the law as it is applied and practiced in developing legal systems, while having an incredible cultural immersion and exchange in the beautiful sub-tropics of Southeast Asia.

**Course:** Teaching Law, Human Rights and Ethics by SUN Program of Central European University with Public Interest Law Institute (PILI) and Columbia Law School in Budapest, Hungary.

**Theme:** This is a one-week course for junior and mid-career law faculty, as well as senior students interested in pursuing an academic career, who will learn more about the use of innovative methods of teaching and who will be expected to have an impact on reform of legal education through their own curricular innovations. The course has three components - human rights, legal ethics and teaching workshops. Participants will discuss the political and ethical implications that arise as lawyers expand their practice to encompass public interest law and international human rights. The third component of the course is a workshop, designed to experiment with innovative ideas of teaching human rights and legal ethics. Small groups of participants will develop teaching plans and will present an excerpt from the class to the whole group. Applications from all over the world are encouraged. The deadline is February 16, 2009. Financial aid is available.
