News: Call for Papers - 5th International Journal of Clinical Legal Education conference, Johannesburg,

Date: 9th and 10th July 2007

Theme: Unity in Diversity

Details: The 5th IJCLE conference is being held in Johannesburg on 9th and 10th July 2007, in conjunction with the South African clinical legal education conference.

The IJCLE conferences bring together legal educators from all jurisdictions with an interest in clinic and other forms of pro bono and experiential learning. The theme of this year's conference recognises the particular contexts of the South African clinical movement in supporting legal education in South Africa's move to a democratic multi-cultural environment. The topics for the 5th IJCLE conference include social justice through legal education; clinic and the law school curriculum; assessment within a social justice environment; and unity and diversity in clinical law experiences.
